Manfred is Director and Co-founder of KDVI. Bringing to bear his knowledge and experience of economics (Econ. Drs., University of Amsterdam), management (MBA and DBA, Harvard Business School), and psychoanalysis (Canadian Psychoanalytic Society and International Psychoanalytic Association), Kets de Vries scrutinises the interface between international management, psychoanalysis, psychotherapy and dynamic psychiatry. His specific areas of interest are leadership, career dynamics, executive stress, entrepreneurship, family business, succession, cross-cultural management, team building, coaching and the dynamics of corporate transformation and change.

He is also Professor of Leadership Development and Organisational Change at INSEAD.
